f. Tax-Free Childcare opens to under 9s

Tax-Free Childcare opens to parents whose youngest child is under 9. The scheme will open to all remaining eligible families on 14 February 2018. This means all eligible parents will be able to apply for Tax-Free Childcare before the end of this financial year. Since opening the childcare service, through which parents apply for 30 hours free childcare and Tax-Free Childcare, more than 325,000 customers have successfully applied and are now using the service. Of these, more than 170,000 have a Tax-Free Childcare account. They'd be very grateful for your support in communicating with local parents on this. There are resources to help you do so on the <u>Childcare Choices website</u> and in the <u>communications toolkit</u>.

Parents, including the self-employed, can apply online for Tax-Free Childcare by visiting the Childcare Choices website. Parents can also access the government's childcare calculator through Childcare Choices, which helps parents to choose which government childcare support is best for them.

-Small Talk is a language course for parents/carers with children aged from 12 to 24 months of age or developmentally fitting into that age range.

-This course provides parents/carers with lots of practical ideas and strategies to help their child develop good communication skills.

-Parents/carers are signposted to services and organisations that give good advice and support.

-Parents/carers may be concerned that their child is not using as many words as other children they know.

-They may have had other children who found acquiring communication skills difficult and would like to know how they can help.

-Parents/carers might be interested in finding out how children acquire speech and language skills and would like to know about the developmental stages of speech and language.

Building Blocks for Language

-Building Blocks for Language is a course for parents with children from 24 months to 36 months of age or developmentally fitting into that age range.

-The course provides parents/carers with lots of practical ideas and strategies to help their child develop good communication skills.

-Parents/carers are signposted to services and organisations that give good advice and support.

-Parents/carers may be concerned that their child is not making the same progress in acquiring speech and language skills as other children at the same age.

-Parents/carers may have already had a child who had difficulty with speech and or language and want to get some advice and support.

-Parents/carers may want to make sure that their children are 'school ready' and that they have the skills and information to help.
