Clarification on Two-year-Old Funding Codes

To clarify the difference between the two-year-old funding codes; the two-year-old funding codes awarded under the disadvantaged criteria are **six** digits long and can be a mixture of letters or numbers. Codes awarded under the working parent entitlement are **11** numbers long.

Disadvantage Two-Year-Old Funding Take Up – Autumn Term 2023

We would like to thank providers for their continued hard work to ensure children are able to access an early year's place if eligible for the disadvantage two year old funding. In Autumn 2023, the take up rate in North Yorkshire was 93% and higher than the national average of 74%. Thank you for making a difference.

Apprenticeships Update from 1st April 2024
