School Census Reminder											
<p>Audience: All schools</p> <p>Schools Census day was Thursday 17th May 2018. The DFE guidance notes have been updated on the CYPS.info pages and an updated summary article describing what is needed for this return is also available. For Schools who purchase support from Schools ICT there are School Census preparation and guidance notes available on their website for Capita Sims, Bromcom, Integris, and Scholarpack, you will need to login to the website to access the documents.</p> <p>The deadline for all returns to be submitted and approved by the LA is Wednesday the 13 June 2018. Please ensure your return is completed and submitted to the LA, or directly to the COLLECT website, before this date to allow time for the LA to address any issues with your data. If you wish to make any changes to the data submitted or make a resubmission please contact the Local authority as soon as possible. The LA will contact you if there are any issues with the data you have submitted and also if there are any Duplicate pupils or Duplicate UPN's that need resolving. The database will close to amendments from schools and local authorities on Wednesday 4 July 2018.</p> <p>Academy schools submit their returns to the DFE on COLLECT, accessed through Secure Access, and the LA does not have access to amend or review that data until after the DFE have approved the returns. Academy schools must also access the reports relating to duplicate pupils and ensure these are resolved before the deadline of the 4th July 2018.</p>		<p>Cascade to:</p>

Early years guidance for Heads & Governors on the admission of 2 & 3 year olds to schools.

This guidance applies to maintained schools including Voluntary Aided, and Voluntary Controlled schools. Academies and Free schools to ensure that early years provision meets the requirements of the Early Years Foundation Stage and all relevant regulatory frameworks. This 2018 version updates information about the ways in which provision for pre-statutory aged children can be made in schools and the processes required when schools are considering new or different early years provision.
