No amendments can be made to KS1 teacher assessment judgements after the **27**<sup>th</sup> **June 2023** without approval from the LA or STA. No amendments can be made to KS2 teacher assessment judgements after the **30**<sup>th</sup> **June 2023** without approval from the LA or STA.

- EYFSP, KS1 and Y1/2 Phonics CTF files must be submitted to the LA.
- KS2 teacher assessment results must be submitted to Primary Assessment Gateway

## Submission of data to the LA

If you are using a 3<sup>rd</sup> party pupil tracker please can you export the data from your software and then upload the data into the school MIS (NYES Digital would be able to assist with the import) and then follow the instructions to export the data from the MIS. If this is not possible then please export your CTF from your tracking software and send to the LA via S2S.

Please submit the LA export file to us using S2S, please DO NOT use Anycomms to submit your file.

Both pupil level and school level summary reports will be distributed to schools every day during the collection period via Perspective Lite. The reports will act as a receipt that we have received your information and will allow you to check that all your pupils have been uploaded to our system and that there aren't any errors.

Please check the reports in Perspective Lite and let me know of any errors as soon as possible.

If you need to resubmit any of the information, please include <u>all pupils</u> on the resubmitted CTF file and not just new pupils/amended information.
