School Funding Update

1.0 PURPOSE OF THE REPORT

- 1.1 This report provides:
 - an overview of school funding issues related to the national funding formula (NFF) developments for the 2023/24 financial year
 - details of changes to the Central Schools Services Block (CSSB) of DSG funding for the 2023/24 financial year.

2.0 BACKGROUND

- 2.1 In Autumn 2017, the Department for Education (DfE) announced national changes to the school funding formula that will eventually see all mainstream school budgets set using a national funding formula. To date, a 'soft' approach has been undertaken where the funding that local authorities receive is based on the new formula but there continues to be a degree of local decision in terms of determining the funding formula values and factors used within each local authority area.
- 2.2 The Schools Forum has adopted an approach of calculating school budgets using the NFF principles as far as possible since the introduction of the formula in 2018-19. The DfE have stated their expectation to move to the direct NFF by the 2027-28 funding year at the latest. The DfE have recently consulted on the transition to the direct NFF through the "Implementing The Direct National Funding Formula" consultation that closed on the 9th September 2022 further detail on the consultation is provided in section 7 of this report. For the 2023-24 financial year, the DfE have set out a number of requirements to bring local funding formulae closer to the schools NFF. These requirements relate to:
 - local authorities will only be allowed to use NFF factors in their local formulae
 - local authorities must use all NFF factors except for the locally determined premises factors which remain optional
 - local authorities must move their local formula factor values at least 10% closer to the NFF, except where local formulae are already mirroring the NFF
 - local authorities must use the NFF definition for the EAL factor, although flexibility over the sparsity factor methodology will remain in 2023 to 2024

The NYCC school funding formula already complies with these requirements.

- 2.3 The Government announced in the Autumn 2021 Spending Review that the total core school budget would increase to £56.8 billion by 2024-25, providing a £7 billion cash increase compared to 2021-22. The 2023-24 financial year is the second year of the three-year funding settlement. The DfE have stated that "overall, core schools funding (including funding for mainstream schools and high needs) is increasing by £1.5 billion in 2023-24 compared to the previous year, on top of the £4 billion increase in 2022-23. Funding through the schools NFF is increasing by 1.9% overall in 2023-24, and 1.9% per pupil, compared to 2022-23.
- 2.4 The local funding formula within North Yorkshire for the 2022-23 financial year included the following key points in terms of the calculation methodology used:
 - A Minimum Funding Guarantee of +2.0%
 - No cap on funding gains

- Funding formula factor values based on the DfE National Funding Formula (NFF) values.
- The application of the mandatory minimum per pupil level funding values of £4,265 for primary schools and £5,525 for secondary schools.
- The provision of an exceptional circumstance lump sum of £50,000 for very small sparse secondary schools that meet the following criteria:
 - pupils in years 10 and 11
 - 350 pupils or fewer
 - a sparsity distance of 5 miles or more
- No funding transfer from School budgets to the High Needs budget
- 2.5 The local authority has continued to lobby DfE and MPs for a better funding deal for children and young people in all North Yorkshire education settings (including maintained schools and academies). Previously stated concerns remain with regard to school funding levels in relation to small secondary schools, secondary school sparsity funding, and the level of the high needs funding quantum.

3.0 EDUCATION FUNDING POLICY: 2023/2024 SCHOOLS BLOCK

3.1 On the 19th July 2022, the DfE announced the proposed school funding arrangements for the 2023/24 financial year indicating, nationally, an overall increase of 1.9% compared to 2022/23. The Institute of Fiscal Studies recently highlighted:

"On top of rising energy and food prices, schools now also face the cost of rising salaries for teachers and support staff. Within the context of a £4 billion rise in the school budget this year, these costs look just about affordable – at least on average. Next year looks much more problematic, however, with growth in funding per pupil expected to fall below growth in school costs. Indeed, the fast rises in school costs will reduce school budgets' purchasing power and leave spending per pupil in 2024 still about 3% lower in real-terms than in 2010.

The big fiscal choice for policymakers this autumn is whether or not to provide more funding to public services to compensate for rising costs and the significant challenges they face. It will be that much harder for schools to meaningfully contribute to levelling-up ambitions when they face real-terms cuts from next year onwards"

- 3.2 The key updates to the NFF for 2023-24 are as follows:
 - The core factors in the schools NFF (such as the basic entitlement, and the lump sum that all schools attract) will increase by 2.4%.
 - Additional support is directed to disadvantaged pupils, with the FSM6 and IDACI factors in the schools NFF increasing by 4.3% compared to their 2022/23 values.
 - Rolling the 2022-23 school supplementary grant into the schools NFF ensuring that this additional funding forms an on-going part of schools' core budgets. Appropriate adjustments have been made to NFF factor values to reflect this, adding £97, £137 and £155 to the primary, key stage 3 and key stage 4 per pupil funding factors respectively; £85 and £124 to the primary and secondary FSM6 factors; and £3,680 to the school lump sum.

- The minimum per pupil funding levels will ensure that every primary school receives at least £4,405 per pupil, and every secondary school at least £5,715 per pupil. The minimum per pupil funding levels are mandatory in 2023/2024. The funding values include £119, £155 and £173 per primary, KS3 and KS4 pupil respectively for the rolling in of the schools supplementary grant, plus a further 0.5% increase. The average amounts in respect of the supplement grant reflect the average level of funding these schools currently attract through the grant.
- Every school will be allocated at least 0.5% more pupil-led funding per pupil compared to its 2022-23 baseline (increased to take account of the rolling in of the schools supplementary grant)
- Local authorities are able to continue to set a Minimum Funding Guarantee (MFG) in local formulae, which in 2023-24 must be between +0% and +0.5% (comparable values for 2022/23 were +0.5% and +2.0%)
- Following the cancellation or incompleteness of assessments in summer 2020 and summer 2021 due to COVID-19, this data is unable to be used as part of setting a low prior attainment factor in local funding formulae. Instead, the 2019 assessment data will be used as a proxy for assessments which would have taken place in 2020 and 2021.
- Local authorities continue to be able to transfer up to 0.5% of their schools block to other blocks of the Dedicated Schools Grant (DSG), with school's forum approval. A disapplication request is required for transfers above 0.5%, or for any amount without school's forum approval.
- Appendix 1 to this report provides a comparison of the 2022-23 local funding formula values for North Yorkshire to the 2023/24 NFF values
- 3.3 Whilst the increased levels of sparsity funding received in 2022-23 is welcome, as previously highlighted, the financial challenges faced by our small rural secondary schools continues to be very concerning. It is extremely disappointing that the DfE have not delivered any funding formula developments in the 2023-24 financial year to provide additional much needed funding for these schools. In their recent consultation (details provided in section 7 of this report) the DfE are proposing to automatically incorporate the additional funding that local authorities can provide to very small, rural secondary schools, on top of existing sparsity funding into the sparsity factor. The DfE propose to make this modification "in time for the introduction of the direct NFF". The DfE have provided no commitment in respect of the additional funding to be provided through this formula development. NYCC continues to rigorously lobby DfE and local MPs on this issue.
- 3.4 As a continued interim measure, the LA proposes to continue to provide the exceptional circumstance funding of £50,000 for very small sparse secondary schools, which would otherwise be unable to attract sufficient funding to remain viable. Local authorities can only make an application for this where schools have:
 - pupils in years 10 and 11
 - 350 pupils or fewer
 - a sparsity distance of 5 miles or more

Based on the 2022-23 data, two schools would be eligible to receive this funding; however, based on current pupil number projections for October 2022, one of the schools is unlikely to be eligible as pupils numbers are forecast to increase above 350 pupils. It is expected that the approval provided by the DfE to NYCC for the provision

of the exceptional circumstance funding for very small sparse secondary schools in 2022-23 can be carried forward to 2023-24.

- 3.5 The funding requirement for the provision of the additional lump sum to small sparse secondary schools would be £50k £100k (dependent on the number of schools meeting the criteria). Funding provision is now incorporated within the 2023-24 schools block DSG funding due to the DfE funding methodology of the Premises element of this funding allocation at LA level reflecting the 2022-23 funding allocated to schools for the formula factors included within this element. In this respect, there is no requirement to utilise Schools Block DSG Reserve for the provision of this funding, as was the case in 2022-23.
- 3.6 The DfE have produced notional individual school allocations for 2023-24 reflecting the changes in the NFF. It should be noted that the notional NFF allocations released in July 2022 are based on the October 2021 census and final 2023-24 funding allocations, updated to the October 2022 census pupil number and other data changes, will not be available until December 2022.
- 3.7 North Yorkshire County Council is not requesting a transfer of funding from the Schools Block to the High Needs budget for the 2023-24 financial year.
- 3.8 Extensive financial modelling has been undertaken on the notional NFF 2023-24 funding allocations and options for the setting of the MFG level for 2023/24. This modelling, based on the 2023-24 funding information received to date from the DfE, indicates that in applying the NFF factor values and dependent on the level of MFG operated, there is possibility of surplus funding being available for allocation to school budgets. In order to ensure that the main consideration of the school funding consultation is focused on the prime decision regarding the level of the MFG for 2023/24, detailed modelling is not being provided in respect of the distribution of any surplus funding as the actual position will only be known once the final funding allocation, schools will be asked to provide a view, in principle, as to in the event of there being surplus funding available whether this funding should be distributed by an addition to the lump sum or to the age weighted pupil unit (AWPU) value. The following MFG models have been developed:

Option	MFG %
1	0%
2	0.5%

The modelling has identified the following:

- i. Based on the like-for-like comparison* between the 2022-23 actual funding level, including supplementary grant and the indicative 2023-24 funding level, the levels of funding increase across schools range from 0.0% to +2.76%. There are two main reasons for this:
 - Those schools where a low level of funding increase is forecast are typically those schools that are receiving funding under the MFG or MFL and the funding increase reflects the MFG or MFL funding increase as a proportion of the school's overall budget allocation or received MFG or MFL funding in 2022-23 and their funding baseline for the 2023-24

financial year reflects this additional funding protection thus impacting on the funding increase for 2023-24.

• Those schools where a higher level of funding increase is forecast are typically those schools in receipt of higher levels of FMS6 and IDACI funding, thus benefiting from the higher funding increase (4.3%) to these factor elements of the NFF in 2023-24.

(*The 2022-23 baseline funding figure has been adjusted (+/-) for those schools and academies where there will be an adjustment to the level of business rates funding (and associated charge) of greater than \pounds 1,000 between the 2022-23 and 2023-24 financial years. This ensures that a like-for-like comparison is provided to the 2023-24 indicative funding level. Schools and academies in this scenario are marked * on appendix 2a)

- ii. The number of primary schools forecast to be funded on the MFG is forecast to reduce from 66 schools in 2022-23 to 20 or 36 schools in 2023-24, dependent on the MFG level option used. The number of secondary schools funded on the MFG is forecast to reduce from 5 schools in 2022-23 to 3 or 4 schools (dependent on MFG option used) in 2023-24.
- iii. The number of primary schools forecast to be funded on the Minimum Level of Funding is forecast to reduce from 46 schools in 2022-23 to 32 schools in 2023/24. The number of secondary schools funded on the Minimum Level of Funding is forecast to reduce from 14 schools in 2022-23 to 7 schools in 2023-24.

The results of this modelling can be found in **Appendix 2a-b** to this report.

The Local Authority intends to consult schools and academies within North Yorkshire on the level of the MFG to be set for 2023-24 and the methodology to be used for allocation to school budgets of any surplus funding available within the Schools Block DSG after the calculation of the school funding formula using NFF values. **Appendix 3** to this report provides the Equalities Impact Assessment associated with the proposals.

- 3.9 The 2023-24 indicative funding figures received from the DfE currently exclude Growth Funding. The local financial modelling has been undertaken on this basis. The actual Growth Funding allocation for 2023-24 will not be known until December 2022. Growth Funding is planned to be utilised to provide funding for:
 - Pupil Growth & Falling Rolls contingency funds
 - The funding for additional year groups in new schools as provision is expanded each academic year until the school is fully operational
 - Developing the reserve for the planned c.5-7 new schools over the next 5 years which the LA is expecting to be mainstream free schools under the DfE free school presumption process and, as such, require an additional funding commitment from the LA in respect of pre-opening funding, post-opening diseconomies funding and delegated budget in relation to estimated pupil numbers.

4.0 EXCEPTIONS TO THE FORMULA

- 4.1 Local authorities are able to submit a request to the Secretary of State for exceptional circumstances where the 'normal' operation of the formula would not be appropriate or does not recognise a particular scenario. Requests for exceptions to the formula for 2023-24 usually need to be submitted to the DfE by either mid-October (first submission round) or mid-November (second submission round). Members of the Schools Forum are asked to agree to continue with our current exceptions in relation to exceptional rent costs as detailed in 4.2 below.
- 4.2 An exception is currently in place for schools where their rent costs are in excess of 1% of their delegated budget. This exception can only be requested where the number of schools affected equates to fewer than 5% of the schools and academies in the authority. In order to comply with the "fewer than 5%" criteria over recent years it has been necessary to apply additional criteria to reduce the number of schools that are eligible to receive exceptional rent funding through the formula.
- 4.3 The criteria introduced to scale back the number of schools was an impact level of over £10,000 (subject to the value being greater than 1% of the school budget), or an impact level of greater than 1.5% of budget and greater than £4,500. Analysis has been undertaken of the schools where property rental is essential for the delivery of statutory educational provision and where the costs are greater than 1% of their delegated budget. This analysis has highlighted that due to school closures and with rental costs for some schools now being lower than 1% of their budget, it is no longer necessary to implement the local criteria in order to meet the DfE "fewer than 5%" criteria.
- 4.4 In the 2023-24 Schools Funding Operational Guidance, the DfE have informed local authorities that a new exceptional circumstances disapplication request is required where the current approval is prior to 2018-19. In this regard, the Schools Forum is asked to support the submission of a new exceptional circumstances disapplication request to the DfE to provide funding for those schools where property rental is essential for the delivery of statutory educational provision and where the cost is greater than 1% of the school's delegated budget. It is anticipated that 14 schools and academies will receive funding, with values ranging from £6.1k to £93.4k. The estimated funding requirement is within the value of 2022-23 funding exceptional rents funding allocated to schools, which is the funding amount provided by the DfE for 2023-24.

5.0 INTENTION TO CONSULT

- 5.1 The local authority intends to consult schools and academies within North Yorkshire on the following items:
 - The level of the MFG for 2023-24
 - The methodology for the allocation to school budgets of any surplus funding available after the application of the NFF factor values in the North Yorkshire funding formula.

A copy of the Equalities Impact Assessment associated with the consultation can be found in **Appendix 3** to this report.

6.0 SCHOOL COST PRESSURES

- 6.1 The 2023-24 overall increase in school funding of 1.9% needs to be considered in the context of the significant cost pressures faced by schools in respect of:
 - September 2022 teachers pay award of 5% with an increase of 8.9% in starting salaries
 - A National Employers offer of £1,925 on all NJC salary points from 1st April 2022 plus a 4.04% increase on allowances. This equates to a 10% increase for staff on lower salary bands.
 - Energy cost increases of in excess of 200%
 - Overall general inflation in excess of 10%
 - Further pay award and cost increases forecast for 2023-24

7.0 DFE CONSULTATION "IMPLEMENTING THE DIRECT NATIONAL FUNDING FORMULA"

7.1 The DfE have recently undertaken a consultation on "Implementing the Direct National Funding Formula". The consultation ran from 7th June 2022 to 9th September 2022. A summary of the consultation items is provided in the below:

8.0 CENTRAL SCHOOL SERVICES BLOCK (CSSB)

- 8.1 The Central School Services Block was introduced in April 2018 and covers a range of services that are not delegated school responsibilities. These services support LA-maintained schools and academies alike and have previously been funded from council (non-DSG) budgets, which have been top-sliced and allocated back to each authority in this new DSG block.
- 8.2 The following services are funded from CSSB:
 - Strategic Management Costs, including planning for the education service as a whole
 - Revenue budget preparation, monitoring, internal and external audit, funding to schools
 - Consultation costs
 - Plans involving other LA services
 - SACRE
 - Schools attendance and exclusion issues
 - Employment of children
 - Capital programme
 - Landlord responsibilities

- 8.3 The CSSB currently relates to both ongoing responsibilities and historic commitments. The provisional figures provided by the DfE for 2023-24 indicate that North Yorkshire will see an increase in the level of funding received for ongoing responsibilities of 2.28% per pupil. The DfE have indicated that the CSSB relating to ongoing responsibilities includes a protection to ensure no LA sees losses of greater than 2.5% per pupil, year-on-year, for 2023-24. From 2020-21, the DfE began to reduce the element of funding within the CSSB that some local authorities received for historic commitments made prior to 2013-14, stating *"We do not believe it is fair to maintain indefinitely significant differences in funding between local authorities which reflect historic decisions."* In 2023-24 the historic commitments funding will reduce by a further 20% on 2022-23 allocations.
- 8.4 Based on the indicative CSSB figures provided by the DfE for the 2023-24 financial year there will be an overall funding reduction for North Yorkshire of £124k compared to the 2022-23 funding level; a £183k reduction related to historic commitments and a £59k increase related to ongoing responsibilities. The level of historic commitments totals £1.14m and relates to services provided by the Early Help service. The local authority will need to look at how to deal with the funding reduction. As with previous years, the LA is not proposing, at this stage, to top-slice school budgets to fund any central services for schools in 2023-24.

When did the due regard process start?	In setting School Funding each year, it is necessary to consider the level at which the Minimum Funding Guarantee (MFG) is set within the parameters determined by the DfE. This EIA considers this issue in respect of 2023-24 School Funding.

The EIA considers the review of the level of the MFG to be used in determining school budgets for the 2023/24 financial year.

The MFG is a protection mechanism which determines the minimum funding uplift which every school will receive in terms of funding per pupil between the 2022/23 financial year and the 2023/24 financial year.

The DfE school funding guidance for 2023/24 allows local authorities to continue to be able to set a MFG in local formulae, which in 2022/23 must be between 0% and +0.5%. This allows every school, dependent on the local decision on the level of the MFG, the opportunity to benefit from the 0.5% more pupil-led funding per pupil compared to its 2022/23 National Funding Formula (NFF) baseline.

The EIA also considers the methodology which will be used to allocate to school budgets any surplus funding remaining in the Schools Block Dedicated Schools Grant (DSG) after the school funding formula allocations have been calculated using the NFF values as determined by the DfE.

The DfE require each local authority to determine the level of the MFG to be used within their local school funding formula each financial year.

In order to ensure that schools receive optimum benefit from the Schools Block DSG funding consideration needs to be given to the methodology for the allocation of any surplus funding remaining after the calculation of school funding formula allocations using the NFF values as determined by the DfE.

The impact on individual schools may vary in relation to the proposed level of the Minimum Funding Guarantee (MFG) to be implemented in 2023/24 and the methodology used to allocate any surplus funding remaining in the Schools Block DSG after the calculation of school funding formula allocations using the NFF values as determined by the DfE.

The DfE released their 2023/234 funding announcement and the associated detailed funding information required to model funding formula options for the next financial year in July 2022. A consultation will be undertaken with schools and academies will be undertaken between 28th September 2022 and 9th November 2022.

The responses and results from the consultation exercise will be presented at the Schools Forum on 17th November 2022. This EIA will be updated during and following the consultation responses. Schools will be notified of the outcome of this process before the end of November.
