The 30 hour extended entitlement

- Test different approaches that deliver the Government's manifesto promise to working parents
- Consider models of flexible provision which match parental working patterns
- Secure sufficient places in a range of different geographical areas
- Test technical delivery systems, including eligibility checking, to ensure a smooth journey for all customers.
- Positively promote the 30 hours childcare offer to maximise parental take-up



Eligibility

National eligibility criteria families will need to meet:

- Both parents must be working (or the sole parent if in a lone parent family)
- Each parent must have a weekly minimum income equivalent to 16 hours at national minimum wage or national living wage
- Each parent must have an income less than £100,000 per year



Parents are also eligible if:

- Both parents are employed but one (or both) is temporarily away from the workplace on maternity, paternity, parental or parental leave
- Both parents are employed but one (or both) is temporarily away from the workplace on adoption leave
- Both parents are employed but one (or both) is temporarily away from the workplace on statutory sick pay
- One parent is employed and one parent has substantial caring responsibilities based on specific benefits received for caring
- One parent is employed and one parent is disabled or incapacitated based on receipt of specific benefits.

Charging for additional goods and services

- Under current guidance providers are able to make charges for goods and additional services.
- Parents must not be charged any fee for their child's funded place and it must not be a condition of children taking up their place.
- Charges can be made if they are fair and reasonable parents must be informed well in advance of taking up a place. There must be clear billing.
- DfE are to publish Statutory Guidance and issue a national model contract at the end of February
