DfE Early Years Consultation - Funding Rates For Expansion Of Childcare

The government has released a <u>consultation into the funding rates and formula for 2 year olds</u> as part of the expansion of childcare announced in Spring Budget 2023. Two-year-old Funding – Online Application Process

Families need to apply for two year old funding via the online application form at <u>Early years funding for 2</u> <u>year olds | North Yorkshire Council</u> If further support is required, contact Families Information Service on <u>fis.information@northyorks.gov.uk</u> Please <u>do not</u> use the term "Golden Ticket letter" with families as they think they do not need to apply. Following stricter data sharing agreements in 2021 between the DfE and all local authorities, the term and associated process of "Golden Ticket" letters has not been used in North Yorkshire.

EYFS Statutory Changes – September 2023

A reminder that, following a DfE consultation from July – September 2022 and confirmation published March 2023, the following changes to the EYFS Statutory Framework will come into force from 4th September 2023:

• a change to the current statutory minimum staff:child ratios in England for 2-year-olds from 1:4 to 1:5;

• clarifying that childminders can care for more than the currently-specified maximum of three young children, when caring for siblings of children they already care for, or when caring for their own child; and

• clarifying that "adequate supervision" while children are eating means that children must be within sight **and** hearing of an adult (rather than the current wording of "sight **or** hearing").

An updated version of the EYFS (which will apply from 4 September 2023) is available on <u>GOV.UK website</u> <u>Statutory framework for the early years foundation stage (publishing.service.gov.uk)</u> alongside the current version of the EYFS (which still applies until 4 September 2023).

It is also for NYC staff working in Early Help, Social Care, Foster Care and Inclusion as well as colleagues in Healthy Child Team and parents in North Yorkshire.

The **free** training aims to empower early years practitioners to deliver inclusive practices through training and shared information/learning resources.
