The Department for Education (DfE) early years recruitment campaign is launching on **Friday 2 February**. The aim of the campaign is to promote early years and childcare careers by highlighting the huge difference early years professionals make to young children and how rewarding working in the sector is. Early years providers can list their vacancies on Find a Job ahead of the campaign launch.

You should use the term 'early years' in the title of your job adverts and select 'Education jobs' for the job category.

Please watch these <u>video tutorials</u> to help you create an employer account, and post any current or upcoming roles in your setting. The campaign, with its own dedicated website, will direct potential applicants to use DWP's <u>Find a Job</u> vacancy platform to search for early years, childcare and wraparound roles in their area.
