General Election and pre-election period - Childcare Expansion Programme

York and Scarborough Hospital - Speech Therapy Team Workshops

As you are aware, a general election was announced for 4th July and local authorities have entered the preelection period. There will be no social comms etc. issued by the LA during this period. The DfE has advised that plans for the implementation and delivery of the childcare expansion programme should continue as usual during this time.

Government Funded Entitlements: Since 1 April 2024 eligible working parents have been entitled in law to 15 hours a week of early education and childcare for children from the term after they turn 2. The law provides that from 1 September 2024, eligible working parents will be entitled to 15 hours a week of early education and childcare from the term after they turn 9 months. Parents are applying for codes for September places currently.

Early Years Funding

Reminder to providers that they must check the validity dates of working parent eligibility codes well ahead of a child starting their place in September - this is especially important for those providers who close for the summer holidays. Where parents have confirmed taking up a place, providers must have validated these codes via the Synergy Web Provider Portal before they close for the summer. This is an important step to ensure that parents are accessing public funding for a place to which they are entitled, but it also allows government to monitor national and local level sufficiency. Armed Forces Covenant Grant Fund

The Early Years programme is live on the Armed Forces Covenant fund trust website and social media channels. <u>Armed Forces Families Fund: Early Years programme 2024-25</u>: <u>Armed Forces Covenant Fund Trust</u>

Early years providers can apply for a grant of between £5,000 and £50,000. Your project must clearly benefit Armed Forces families with a child under 5 years old by enhancing their access to high quality childcare.

There are three focused outcomes. Your project will need to contribute towards at least one of these outcomes.

Increased capacity at the setting to allow more Service children to attend.

- Better learning environments for Service children.
- Have provided appropriate training and development to staff to support Service children.

There will be two application deadlines:-

24 July 2024. You'll receive a decision before the end of September 2024.

20 November 2024. You'll receive a decision before the end of March 2025.

Applications received after 12 noon on 20 November won't be considered.

The trust invite applications from:

 Early childhood education and childcare providers operating where Armed Forces families live or work and must offer group-based childcare and have at least 50% of Service children on roll (unless under a cluster, see below).

•

If your setting has less than 50% Service children on roll, you could still apply as a cluster. This means submitting a group bid on behalf of two or more setting with smaller numbers of Service children. If you choose to apply via this route, you can apply for:

- Staff training with an Armed Forces focus.
- Funding for a shared resource, such as a roving Armed Forces Early Years Support Worker.

Applications will only be received from providers who are registered and inspected by Ofsted and have children not yet accessing statutory school provision.
