#### **DfE Check an Early Years Qualification Service**

Early Years managers and leaders can check details about a qualification and receive a clear outcome that can be printed. The service aims to simplify qualification checks achieved in the UK, reduce admin and save time during the recruitment process. Early years managers can now use the new <a href="Check an early years">Check an early years</a> qualification digital service to quickly verify whether staff qualifications meet the requirements for staff:child ratios. The service is tailored specifically for early years managers. All other user groups (e.g. practitioners) should continue to use the <u>Early Years Qualifications List (EYQL)</u> to check qualifications, and contact <u>Ecctis</u> if they are unable to find the qualification on the EYQL. Holders of non-UK qualifications should continue to contact <u>Ecctis</u> for an assessment.

#### **UPCOMING** - Provider Portal opening for headcount checks – 2<sup>nd</sup>-13<sup>th</sup> June

- ✓ The portal will shortly be reopening for providers to check their headcount submission and make any amendments
- ✓ An email will be sent out on Monday 2<sup>nd</sup> June with instructions
- ✓ Please note, this only relates to children attending on headcount week

#### Summer term 2025 After Headcount Claims

The Portal is <u>not available</u> for providers to submit After Headcount claims yet. If you wish to enquire about making an after headcount claim this term, then please send an email to <u>eyft@northyorks.gov.uk</u> with the following information:

- ✓ The child's full name and date of birth, the date the child is joining you from, how
  many total weekly funded hours you wish to claim. A brief explanation as to why they
  are coming to you to access their funding.
- ✓ After headcount funding is only available if an eligible child has joined your provision from Monday 19<sup>th</sup> May onwards, the child must <u>never</u> have previously accessed funded hours at a North Yorkshire funded provider **at any time**, unless you are a childminder
- ✓ Children accessing working family funding must have a valid code with a start date prior to 1<sup>st</sup> April 25 and an end date after 31<sup>st</sup> March 25
