

Early Years Advisory Teacher (EYAT) Consultation Days

The Early Years Advisory Teachers (EYATs) will be holding Consultation Days during the Spring and Summer terms 2018. On these days they will be in a local base specifically to liaise with SENCOs and practitioners from Early Years settings in relation to children who currently have involvement from the team. Consultation and advice can be provided in relation to SEN processes including:

- Inclusion of children with SEND;
- Discussion and advice around individual children;
- Completing Individual Learning and Provision Plans (ILPPs);
- Completing Behaviour Change Plans;
- Transition planning for children;
- Information about forthcoming training courses;
- Follow-up advice following EYAT courses;
- Information about Portage and other NYCC services;
- CAN Do Assessments;
- Element 2 funding;
- Education, Health and Care Assessment Requests (EHCARs).

Please contact your local EYAT to book a specific appointment during their Consultation Day. It may be that, if several practitioners want help with the same issue, a small-group session/discussion could be arranged.
