Paediatric First Aid EYFS Statutory Requirement

In line with statutory requirement (3.25) it is mandatory that "at least one person who has a current paediatric first aid (PFA) certificate must be on the premises and available at all times when children are present and must accompany children on outings." Full PFA certificates must meet the criteria in Annex A of the statutory framework. Refer to EYFS paragraph 3.25 and Annex A for full details of statutory requirement.

An amazing opportunity to take up <u>free</u> online inclusion training is available for all early years providers, parents and family facing professionals working with children aged 0 – 5 years old in North Yorkshire. Dingley's Promise, funded by Comic Relief, is providing free training for early years providers (childminders, preschool staff, day nursery staff and early years staff in schools), NYCC staff working in Early Help, Social Care, Foster Care and Inclusion as well as colleagues in Healthy Child Team and for parents in North Yorkshire. NYCC is one of 10 local authorities selected this year to be part of this fantastic opportunity. There are 10 modules available to complete over the next five years and the first four modules are available now:-
