## SCHOOL SAFEGUARDING AUDIT 2020-21

Please can all schools complete the school safeguarding audit tool and return this to the NYSCP by Wednesday 31 March 2021. To date a limited number of schools have provided their responses to the safeguarding audit and we would like to thank them for their completion so quickly given the ongoing pandemic.

The School Safeguarding Audit is an important tool for the strategic assessment of the current safeguarding arrangements within schools across North Yorkshire, which will inform a number of activities of the NYSCP. We would like to encourage and reinforce the need for all schools (whether maintained, academy, independent or special) to complete the audit and submit this by 31 March 2021.
