### Digital Devices

- If your school has not already ordered your allocation of digital devices through the DfE then you should follow the process outlined here - <https://get-help-with-tech.education.gov.uk/devices/how-to-order>
- If you wish to query your allocation of devices you can do so here. <https://get-help-with-tech.education.gov.uk/devices/device-allocations#how-to-query-an-allocation>. The DfE is currently prioritising delivering each school their current allocation to make sure they have devices to lend to pupils. **However, if schools do not have enough devices for the students who need them then you may consider querying your allocation.**

### Internet access

- There is a scheme to temporarily increase data allowances for mobile phone users on certain networks. This is so that disadvantaged children and young people can access remote education, and they do not have access to broadband at home. Schools and trusts can request more 4G wireless routers for disadvantaged children in years 3 to 13 who are experiencing disruption do not have a broadband connection or access to the internet at home.
