'Safeguarding Update' Training for schools

How do you keep up-to-date with safeguarding issues that are putting children and young people at risk? Equalities up-dates

Prejudice based incidents and hate crime reporting. Are you using the new reporting process?


Revised 'Guidelines for dealing with and reporting prejudice based incidents and hate crimes in schools and settings' were sent to schools in the e-red bag in late September, and are available on the CYPS info site under safeguarding and in Fronter in the Equalities Room.

These guidelines will help schools fulfil their duty to eliminate discrimination, harassment and victimisation and their duty to foster good relations, under the Equalities Act (2010) and the Public Sector Equalities Duties (2012). It provides schools with information about how to deal with and report on the frequency and extent of prejudiced based incidents within school.

The revised reporting system requires schools to inform the Local Authority of each prejudice-based incident as it happens, rather than waiting for an end of term summary report. The guidance and reporting tool can be found at: http://cyps.northyorks.gov.uk/hate-incidents

Pupils are not identified by name in the reporting process, so the details are confidential. The Local Authority will not follow up individual cases (it is up to the school to do this), but will monitor emerging trends and identify where additional support may be needed.

Safeguarding up-dates

Substance Misuse Update (drugs)

We are aware of a number of areas in the county who appear to be managing a perceived increase in the number of young people using drugs. As you all know a PSHE curriculum has to be flexible and respond to the needs of the pupils so you may need to reflect on your drugs and alcohol education to ensure it is meeting the needs of your pupils.

There does appear to be some cases of young people being 'groomed' to become drug sellers in their areas. They are being supplied with substances for 'free' and then being asked to repay back for what they have used and they are asked to do this by selling to other young people in their local community. The Police are calling this approach County Lines more information can be read at http://www.nationalcrimeagency.gov.uk/publications/832-county-lines-violence-exploitation-and-drug-supply-2017/file so when considering your education about grooming this maybe a further aspect to consider.

The NYCC substance misuse guidance for schools is presently being updated in partnership with North Yorkshire Police.

Online safety

Online safety continues to be a significant area of concern for many schools.

Revised North Yorkshire guidance for schools was issued in September 2017 and is backed up by a range of training opportunities for schools (see above in the training section). The guidance can be accessed at http://cyps.northyorks.gov.uk/online-safety

Schools can also book online safety training for all staff to run in their school (2 hour session) and a parents' awareness raising session (1 hour). The training for staff is an essential aspect of the schools safeguarding duties.

Relationships and Sex Education (RSE) will become statutory for all schools from September 2019 and there will be a consultation as to whether wider aspects of PSHE will also become statutory

Ian Bauckham CBE has been appointed by the Department for Education to provide advice on how relationships and sex education, should be taught in schools. As part of his new role, he will speak to parents, teachers, children and other interested groups about the topics that young people today need to understand to stay safe and happy, including age-appropriate content on mental wellbeing, keeping safe online and LGBT issues.

The document covers:

- what sexual violence and sexual harassment is
- what schools' and colleges' legal responsibilities are
- creating a whole school or college approach to safeguarding and child protection; and
- how to respond to reports of sexual violence and sexual harassment

The document starts off with relevant definitions, to develop a shared understanding and importantly, the definition of consent is stated. Please remember the PSHE association does have a teaching and learning resource for secondary aged pupils to help teach about consent https://www.pshe-association.org.uk/curriculum-and-resources/resources/guidance-teaching-about-consent-pshe-education-key

There is an emphasis in the guidance of seeing sexual violence and sexual harassment in the context of developing a whole-school safeguarding culture, where sexual misconduct is seen as unacceptable, and not 'banter' or an inevitable part of growing up. It should be recognised that these issues are likely to occur, and so schools should have procedures in place to deal with them. Groups at particular risk include girls, students who identify as LGBT+, or are perceived by peers to be LGBT+, and pupils with SEND. It is important that schools record incidents across the whole spectrum of sexual violence and sexual harassment, so that they can understand the scale of the problem in their own schools and make appropriate plans to reduce it. In response to the document, schools will need to include the topic in training, develop the knowledge of DSLs, ensure that there are policies and procedures to cover sexual violence and sexual harassment, and understand how to risk assess such behaviours when they occur.

The purpose of RSE is to help children and young people to be safe, healthy and happy as they grow up and in their future lives. RSE must always be appropriate to pupils' age and stage of development and is an essential part of safeguarding. Schools are invited to download and use the statement to make their own commitment to good quality RSE. Whether RSE is already well established, or needs some further development schools can display this statement, share it with parents, staff and governors and use it as a springboard to develop the quality of RSE provision.



Prevent: Run, hide, tell

Security experts from the Counter Terrorism Police have commissioned the creation of an animated core film designed to teach young people how to react if caught up in an a gun or knife terror attack. The film, aimed at 11 to 16 year olds, will also show them what to do if they see suspicious behaviour or a suspicious item.

Versions of the new film for Key Stage 3 and 4 pupils, (ages 11-14 and 15-16), are the cornerstone of teaching material, specially-designed by the PSHE Association and available to Schools and Youth organisations.

Once young people understand the RUN HIDE TELL advice they can progress to TREAT, which has been created in conjunction with St John Ambulance. This age-appropriate First Aid guidance has been specifically designed to allow a teacher or youth leader to show young people how to deliver trauma first aid to an injured person or themselves whilst HIDING and waiting to be rescued by the police.

MYPs choose two key issues for 2018

The UK Youth Parliament, including three members from North Yorkshire, has chosen to focus on lowering the voting age to 16 and a curriculum for life in 2018. The decision came following the Youth Parliament's ninth House of Commons debate, which was chaired by the Speaker, John Bercow MP.



The issues were two of the five topics chosen for debate by people aged 11 to 18 in the Make Your Mark national ballot.

A vote at 16 continues to be an important issue for young people and has been voted as a campaign priority for the second year in a row. Members of Youth Parliament are set to formally launch the

campaigns during their day of action in January. The Youth Parliament will now begin to develop actions for the campaigns ahead.

The North Yorkshire Members of the Youth Parliament (MYPs) are Kitty Jackson, who lives in the Scarborough area and represents the east of the county, around Malton and Scarborough, Eden Shackleton, from the Ripon area, who represents the west, around Harrogate and Skipton and Evie Stevenson, who is from the Selby area and represents the central area, around Northallerton, Richmond and Selby.

They took part in the debate with more than 500 members of the Youth Parliament from across England, Wales, Scotland and Northern Ireland.

Kitty said: "I had a fantastic time representing North Yorkshire East in the House of Commons. It was a great day and I learned a lot about government and the rules of Parliament. I was honoured to be chosen by John Bercow to speak about public transport for children with disabilities and special educational needs.

"The Youth Parliament voted for Curriculum for Life and Votes at 16 to be the campaigns for the next year and I can't wait to get started."

The UK Youth Parliament also welcomed Justine Greening, the Secretary of State for Education and Minister for Women and Equalities, as well as the Minister for Sport and Civil Society, Tracey Crouch, who spoke about the involvement of young people in politics.



Lesbian, Gay, Bisexual and Trans (LGBT) updates



We have updated our **LGBT guidance for professionals who work with children and young people** to support professionals to understand some of the common terms when tackling homophobic, biphobic and transphobic language and supporting LGBT children and young people including a range of local support services in North Yorkshire and local LGBT youth groups. The guidance sets out some recommendations for schools:

- An inclusive school vision 'every child should be revered and respected as a member of a community where all are known and loved by God'
- Clear policies that include homophobic, biphobic and transphobic (HBT)
- Recording incidents of HBT bullying
- Monitoring anti-bullying strategies
- Staff Training
- Supporting pupils
- Collective worship 'inclusivity and dignity and respect for all should be explored'
- Recognising and protecting against HBT bullying
- Curriculum 'Relationships and Sex Education should take LGBT people into account'
- SIAMS

We are offering training for all primary and secondary schools in April 2018 to enable schools to be inclusive and safe for the LGBT community, enable staff to challenge homophobic, biphobic and transphobic bullying and to ensure the school is delivering an inclusive curriculum. Careers Guidance

National Careers Strategy and *Progression for Success*: Careers Guidance in North Yorkshire

On 4th December 2017 the DfE published <u>Careers strategy: making the most of everyone's skills and talents</u>. This national strategy release coincided with the culmination of two years hard work in North Yorkshire, where 18 of our schools and three from City of York have been working towards completion of national careers awards through the *Progression for Success* project.

The National Careers Strategy

The Gatsby Benchmarks

- 1. A stable careers programme. Every school and college should have an embedded programme of career education and guidance that is known and understood by students, parents, teachers, governors and employers.
- 2. Learning from career and labour market information. Every student, and their parents, should have access to good quality information about future study options and labour market opportunities. They will need the support of an informed adviser to make best use of available information.
- 3. Addressing the needs of each student. Students have different career guidance needs at different stages. Opportunities for advice and support need to be tailored to the needs of each student. A school's careers programme should embed equality and diversity considerations throughout.
- 4. **Linking curriculum learning to careers.** All teachers should link curriculum learning with careers. STEM subject teachers should highlight the relevance of STEM subjects for a wide range of future career paths.
- 5. **Encounters with employers and employees.** Every student should have multiple opportunities to learn from employers about work, employment and the skills that are valued in the workplace. This can be through a range of enrichment activities including visiting speakers, mentoring and enterprise schemes.
- 6. **Experiences of workplaces.** Every student should have first-hand experiences of the workplace through work visits, work shadowing and/or work experience to help their exploration of career opportunities, and expand their networks.
- 7. **Encounters with further and higher education.** All students should understand the full range of learning opportunities that are available to them. This includes both academic and vocational routes and learning in schools, colleges, universities and in the workplace.
- 8. **Personal guidance.** Every student should have opportunities for guidance interviews with a career adviser, who could be internal (a member of school staff) or external, provided they are trained to an appropriate level. These should be available whenever significant study or career choices are being made.

highlights the significant impact of a young person experiencing inspiring encounters with further and higher education, and with employers and workplaces- moulding their aspirations from year 8 in preparation for leaving school to education, employment or training. Through excellent advice and guidance programmes schools can engage with their students and help everyone make choices about careers based on the interests and experiences of the learner paired with the data and information available.

The strategy also champions support and guidance tailored to individual needs, referencing the Gatsby Career Benchmarks as a world-class standard for schools and colleges.

The government will be funding the testing of new programmes for careers guidance in primary schools and have included this in their timeline for development, in addition there will be investment for disadvantaged pupils and STEM, 500 'Careers Leaders' will be trained nationally and by 2020: all schools and colleges will have access to an Enterprise Adviser; schools should offer every young person seven encounters with employers - at least one each year from years 7 to 13 – with support from the CEC. Some of these encounters should be with STEM employers; and finally, a new, improved National Careers Service website will include all of the information to help citizens make informed choices.

Progression for Success

Our project schools are in a strong position to face the new strategy and the opportunities it brings. At the time of writing, over half of the schools have achieved a national careers standard, or are in the process of assessment required to achieve this award. Each school, whether or not they currently have an award, has experienced a challenging journey of progress and whole school development during the project. We are working with partners to bring these opportunities to a further cohort this year and will be looking forward to more developments in careers across the county as the year continues.

English as an additional language (EAL) and Gypsy Roma Traveller (GRT) service

The EAL and GRT Service (formerly known as MEA) currently offers free support in school for pupils who have English as an additional language or are from minority ethnic backgrounds, including Gypsy, Roma and Traveller young people.

The January 2017 census indicated that 4.25% of all pupils in North Yorkshire are EAL. The number has increased 10% a year for the last few years, and 2016-17 has seen the arrival of nearly 70 pupils under the refugee resettlement programme.

Supporting EAL pupils effectively, so they reach their full academic potential, can be a challenge for schools, but the service offer a comprehensive range of support for schools, including bespoke support for pupils and staff training.

The EAL and GRT Service is currently free for maintained schools and can be purchased by academies and independent schools. From April 2018, under new funding arrangements, schools are likely to be receiving their EAL budget directly.

The service will be offering a range of specialised pupil support packages, delivered by skilled, experienced practitioners, targeting different areas of development, such as phonics, grammar, reading for meaning and extended writing. Schools will be able to purchase the support for pupils and a wide range of staff training, to enable all staff to effectively support EAL learners.

English as an additional language (EAL) Networks

Improve your skills to effectively support EAL learners, enabling learners with little or no English to make rapid progress.

This network is aimed at classroom teachers and teaching assistants in all schools and settings.

This 2 hour termly network is aimed at classroom teachers and teaching assistants in primary and secondary schools and practitioners in Early Years settings who support EAL learners and want to develop their understanding and skills. The number of EAL pupils in North Yorkshire (including refugees and

asylum seekers) is increasing and outcomes for these learners are often not as strong as they could be. With effective early intervention and differentiated classroom support, these pupils can make rapid progress and achieve high outcomes.

The network meetings are facilitated by the Specialist Advisory Teachers who are based in one of the 6 hub schools across North Yorkshire. The networks are an opportunity for teachers and teaching assistants to improve their understanding of how to effectively support EAL learners, sharing strategies and resources.

The Religious Education Council is currently conducting a review of RE, which includes a debate around the role of ACRE's, whether there should be a National Curriculum for RE and the right to withdrawal from RE. The Commission have produced an interim report, but the final report will be published September 2018.

Consequently, North Yorkshire SACRE have decided to delay a review of our current syllabus until the findings of the Commission are published. The lifetime of the current syllabus will therefore be extended to September 2019.
